



























TERMS & CONDITIONS



PAYMENT Bankers Draft, Bank Transfer, MasterCard, Visa, Switch or American Express.

CREDIT: Approved Credit only –call for application. Net due 10 days of invoice.

Authorized returns in original condition are subject to a 15% restocking charge. Cartons sent back in damaged condition will be charged a slightly higher restocking charge. All returns must be PREPAID FREIGHT. Custom made products or special orders cannot be returned. Prices are subject to change without notice.

WARRANTY: The warranty is extended to the original purchaser.
