

## **INSTRUCTIONS FOR USE**

Powerful action for troublesome Lawn Weeds

FOR USE ONLY AS A HOME & GARDEN LAWN WEEDKILLER. READ ALL SAFETY INSTRUCTIONS BEFORE USE. Maximum individual dose: 500 ml product per 25 m<sup>2</sup>

## WHEN TO USE

Use on leafy weeds April - September when they are small and actively growing and the soil is moist.

# J F M A M J J A S O N D

For best results following spraying, do not cut grass for at least one day after treatment. Avoid spraving in drought or frost. To avoid drift, do not sprav in windy conditions.

DO NOT USE ON NEW-SOWN LAWNS FOR AT LEAST SIX MONTHS AFTER ESTABLISHMENT. Re-treatment may be necessary for well-established difficult to control weeds.

Allow an interval of at least 6 weeks between treatments Maximum number of treatments: 2 per year.

## WHERE TO USE

FOR USE ON LAWNS, for the control of most common broad-leaved lawn weeds. Including problem weeds such as Clover, Daisy, Dandelion, Plantain and Common Chickweed. This pack treats 150 square metres.

## HOW TO USE

### SHAKE WELL BEFORE USE. Always ensure the container is stored and carried upright when not spraving.

Mark out the area to be treated in metre squares.



1. Remove sprayer and pull out the red connector and connecting hose.



2. Insert the red connector into the red receptor on bottle cap until it clicks. Flip up receptor.





4. Apply the spray evenly to leaves and stems. Weeds must be thoroughly wetted to the point of run-off.

5. After use, push connector down, squeeze trigger to clear nozzle, turn nozzle to OFF position and replace the sprayer in the holster without disconnecting the hose.

## CAUTION

Avoid sprav coming into contact with cultivated plants. The first 4 mowings of treated grass must be composted for 6 months before use as a mulch DO NOT dispose of grass clippings via council composting schemes. Scorching of grass can occur if more than one squeeze is applied to a given area. Control may be reduced if rain falls within 24 hours of application.
