## PRODUCT ASSEMBLY INSTRUCTIONS

		
1. Insert the table legs (B) into the slots on the back of the table board (A), and the footpads (C) into the table legs.	2. The table is fully installed.	3. Insert the chair legs (F) into the slots on the back of the seat plate (D), and the chair legs cushion (G) into the chair legs.
		
4. Place the chair on to a flat surface and insert the back of the chair (E) in to the area shown in the figure.	5. Chair Installation Completed.	6. Installation of finished product display.

## CARE/CLEANING INSTRUCTIONS

- Wipe clean with a damp cloth to ensure that the product is completely dry and tidy before storing.
- Store in a dry and ventilated area to prevent mildew.
- DO NOT use bleach or chemical solutions to clean the product.
- DO NOT expose to sunlight or other heat sources for a prolonged period.
- Anti-slip pads are supplied with the table and chairs. These are self-adhesive and can be fixed to the base of the table legs and chair legs (Part B and Part F).
- Anti-slip pads are not suitable for outdoor use. Remove the base in which anti-slip pads are adhered to to use product outdoors and replace it after outdoor use.
